Aug 13 (2:15 pm)	9.3	I have reviewed the record and conclude that the learned Justice did not exercise his discretion judicially when he permitted the certificate of offence to be amended at the end of the Crown's case. The defendant-appellant was thus confronted with a different charge having significantly greater consequences for him than the charge he sought to defend. The appeal is allowed to the extent that the amendment is struck out and a conviction is substituted for speeding at 110 km/h in an 80 km/h zone. <i>Doyle</i>
